The facility carries an interest rate of US LIBOR + 650bps. 100% of Appalachia Net Operating Cashflow is applied to debt repayment subject to minimum amortisation of US\$550,000 per annum.</p> <p>The Facility is secured against oil and gas assets held by the Company's US subsidiaries which comprise the Appalachia gas production assets.</p>
