	<p><b>Senior Secured Facility:</b> the company has a US\$7.5 million debt facility (US\$6.1 million loan availability) with Macquarie Bank Limited which matures in September 2024. The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps. During the Quarter, Empire and Macquarie Bank executed an amendment and reinstatement to the Credit Facility which removed the financial covenants: interest cover ratio and Adjusted 1P PV10 ratio.</p> <p><b>Paycheck Protection Program (PPP):</b> Empire holds a second tranche PPP loan of US\$343,602. The PPP loan was originated through PNC Bank, is fully forgivable provided loan proceeds are used for allowable expenses such as payroll over a 24 week period following loan disbursement, carries a fixed interest rate of 1% p.a. and has a 5 year tenor. The PPP loan is unsecured and subordinated to the Macquarie Bank facility.</p>
